We would like to hereby inform you that, after due consideration, the Board of Directors has decided to change the name of the Sub-Fund “Green Gold” to “Climate Transition”.

#### NAME CHANGE

The Board of Directors has resolved to rename **Carmignac Portfolio Green Gold** because its current name was considered ambiguous by some of our investors and business partners.

The change is as follows:

Current name	New name
Carmignac Portfolio Green Gold	Carmignac Portfolio Climate Transition

We consider that the new name “**Climate transition**” better illustrates the reference to the global challenge of climate change mitigation and adaptation. This reflects the Sub-Fund’s objective to invest in industries and product / service

providers that contribute to climate change mitigation by providing low carbon solutions or transforming their operations and business models to help usher in a low-carbon economy.

We would like to stress that the new name “Climate Transition” will not affect your investment. This change does not impact the Sub-Fund’s existing investment strategy, the way it is being managed, its investment objective and philosophy, or the Sub-Fund’s risks or fees.

This change will be effective on 25 August 2022.
